Disclaimer

The following disclaimer applies to tours of dams, reservoirs, and other river management facilities and events ("Events") sponsored by the Oita Office of Rivers and National Highways, Kyushu Regional Development Bureau, Ministry of Land, Infrastructure, Transport and Tourism (hereinafter referred to as "we"). While we will do our utmost to ensure the safety and security of participants during the Event, we ask for your understanding of these disclaimers.

Please note that those who do not agree with the disclaimer are not permitted to participate.

1. If the event is cancelled or postponed due to weather, natural disasters, or other reasons, no compensation will be provided for any expenses incurred as a result.
We will not be liable for any accidents, injuries, or illnesses that occur during the event, except in cases where the intentional or gross negligence of our staff is obvious. All participants are responsible for purchasing event insurance as necessary.
3. If you have been banned or warned by a physician, you will not be allowed to participate in this event. We will not be responsible for any accidents or injuries resulting from this.
4. Participants must inform us in advance if they have any pre-existing medical conditions, are receiving any medical treatment or medication, or have any allergies or urticaria. We will not be held responsible for any situation that may arise in relation to these conditions.
5. To prevent theft, please take all valuables with you and take responsibility for their safekeeping. We will not be responsible for any theft, loss, damage, etc.
We are not responsible for any accidents that may occur on the way to or from the event. Please be careful to avoid accidents on your way to us.

■ Facilities to be used

We ask that you observe the manners and rules generally accepted in society regarding the facilities you will use for this event. The dam inspection corridor, etc., is a facility for daily inspection and maintenance by our administrator, and is not designed for third-party visitors in accordance with the so-called "Barrier-Free New Law" and so on. Therefore, please note that there are stairs without ramps, steps, narrow sections, and differences in room temperature when entering and exiting underground areas. Visitors in wheelchairs are welcome to visit, but we ask that visitors provide all assistance, including with the stairs.

■ Eating and drinking in the facility

In principle, eating and drinking are not permitted in the dam exhibition rooms and the auditorium. The exception is for rehydration for medication, etc.

■ About Videography

Except for the dam operation room, participants are allowed to take video and photographs. However, we ask for your understanding that our staff and other participants should not be reflected on social networking services (SNS), photo/video posting sites, etc., for publicity to the general public.

■ About this event

We are a dam management facility that responds to disasters. Please note that the content and schedule of this event may be changed or cancelled without notice due to weather, earthquakes, other natural disasters, or other various reasons.
